#### THE BIRTH OF GAY POWER

On July 2, 1969, a new chapter was written in the history of the homophile movement. Outraged at politically-inspired raids on the Stonewall Inn and other gay bars, 400 maile and female homosexuals rioted in the streets of Greenwich Village.

A homosexual riot? The police were astounded, the gay community was astounded. Homosexuals have traditionally been passive in the face of persecution, have traditionally declined to fight their tormentors. Yet bottles and parking meters were hurled, and four poliemen were sent to the hospital. Rioting continued on the following night, and on Wendesday night.

And the homophile groups responded. A Gay Power Vigil was called, cosponsored by the New York Chapter of DOB and the Mattachine Society. On Sunday, July 27, over 500 homosexuals gathered around the fountain in Washington Square Park to hear speeches by Martin O'Brien of Mattachine and Martha Shelley of DOB. They spoke about the potential economic and voting strength of the gay community, about our need for self-respect and the respect of society. And when the speeches were ended, 1,000 people marched down the street to the Stonewall and sang "We Shall Overcome" in Sheridan Square Park.

On Sunday, August 10, 50 homosexuals from Mattachine and DOB, as well as

members of other groups, gathered in a small park in Kew Gardens - the site of another instance of harrassment, the park where vigilantes hadchased homosexuals with flashlights and had cut down trees in order to deny then a place to meet. Speeches were made to the homosexuals and to the localresidents who had gathered around, and a play was put on, the first play written and performed by homosexuals to satirize the heterosexual community. (We need more plays like this -- more art which describes the realities of homosexual life and the realities of heterosexual prejudice, as we see it. We have had enough of their distortions.)

As a result of the vigil in Queens, Miss Shelley was invited to participate in a discussion of Gay Power on WMCA's "Power Line", along withMr. O'Brien and Jerry Hoose of the newly formed Gay Liberation Front on Saturday Night, August 16. They answered questions phoned in by the audience

The theme of these speeches and discussions, indeed of Gay Power itself, is simply that homosexuals are no longer going to wait for a handout from society. We are going to walk in the sunshine at these vigils -- without asking for permission. The theme is self-respect, which we must assume ourselves, since it cannot be granted to us; and our rights as citizens, which we must demand. We are GayPower.

It was interesting to note that the Village Voice, a so-called liberal paper, covered the Stonewall riots in a style that was patronizing and contemptuous. After receiving a flood of angry mail, they covered the first vigil respectfully, dropping such terms as "fagget" and "dyke." The hatred of reactionaries is bad enough--the pity and contempt of liberals has been even more damaging to us. But we have begun to put the liberal community on notice that we will no longer tolerate such attitudes: we are not pitiful, not the "poor sick creatures" of psychoanalytic myth--but a force to be reckoned with. We are a power in the world--Gay Power.

# HOMOSEXUAL SEEKS TO RETAIN SECURITY CLEARANCE

Benning Wentworth, an admitted homosexual, yesterday fought another round in his three-year effort to prevent the Defense Department from revoking his security clearance.

Mr. Wentworth, works for an unidentified private concern that does business with the Goverment. His counsel, Dr. Franklin Kameny, president and founder of the Mattachine Society of Washington and MissBarbara Gittings, a member, argue that Mr. Wentworth's public acknowledgement of his homosexuality frees him from attempts at bribery and coercion that could make him a securityrisk. Neither counsel is a lawyer. Both say they are homosexuals.

"We consider the very existence of this case to be part of the Governments improper, unethical, and immoral effort to enter into the field of private morality, and to force conformity to a particular sexual code," says Miss Gittings.

In the hearing, Defense Department; examiners questioned Mr. Mentworth about the intimate details of his sexual life," Dr. Kameny said.

In 1966, Mr. Wentworth was accused of having had relations with an 18-yearold who had later joined the Air Force.

The youth told a chaplain and a psychiatrist that he was a practicing homosexual. Subsequently, Air Force investigators seized a notebook belonging to him and found Mr. Wentworth's name in it.

The youth later received a general discharge from the Air Force. Mr. Wentworth denied ever having had relations with him.

At a hearing, Mr. Wentworth, who had held a security clearance for material classified "secret" for seven years, was given a statement detailing the charges. After the hearing the Defense Department ruled against him and Dr. Kameny and Miss Gittings appealed the decision.

An appeal board ordered that another hearing be held "to afford department counsel opportunity to examine applicant, and to submit information concerning matters relevant to a determination as to the probability that applicant will continue in the future to engage in sexually perverted conduct."

"We think," Miss Gittings said, "that the only relevant question should be, 'Is this person capable of safeguarding classified material?'"

to radical change regarding the roles women are forced to play in our society. Certainly no "formal" agreement with DOB was intended nor resulted from the appearance of a Women's Liberation group at a DOB discussion. We are just not "into" formality of any sort. We merely want to establish warm relations with any group that is concerned with women's rights in any area, and feel that the time has come for "straight" women to stop being spooked by their homosexual sisters.

Personally, as a member of both Women's Liberation and DOB, I hope very much that informal talks will continue, and that in getting to know each other better, we will smash the barriers of ignorance that keep us apart.
